## SANITARY PROCEDURES FOR THE PREVENTION OF EHV

The following **mandatory rules** have been determined in order to **minimize the risk of spreading the EHV virus amid an important number of horses from different European geographical areas** during the sporting event. Each individual's behaviour will help contain the spread of the disease and facilitate the activities and preventive measures taken by the organizer in this regard.

In the **best interest of animal welfare**, for the organizers of the Futurity is **MANDATORY** a **PCR nasal quick swab test resulting negative at an official laboratory recognized by the national health authorities, the same must be valid for no more than 5 days from the date of the result**. Please reserve the indicated exam in time. **Vaccinated horses will also need to exhibit a negative swab**. **For vaccinated horses is necessary to communicate before sending the test to the laboratory that the horse has been vaccinated.**

Third party horse transporters must show proof of disinfection of the vehicle performed prior to loading the horses have been transported to the event.

*Hereby follows a summary of the obligations and rules of conduct:*

### **Prior to attending the event**

Each owner/rider who has entered one or more horses in the competition will:

- 1) fill in form #1 attached to this communication which must be presented in original at the entrance to the event.
- 2) Carefully fill in the **online registration form** named "PRIORITY LINE" which can be found on [www.salonedelcavallo.com](http://www.salonedelcavallo.com).  
The following is requested on the above-mentioned form:
  - a) Personal data.
  - b) The number plate of each vehicle entering the fairgrounds (including transporters).
  - c) The total number of horses and documentation of each.
  - d) The negative test as described above (original to be delivered at the entrance to the event)

### **Upon entry to the fairgrounds**

Each individual that has filled in the form as indicated above must:

1. **Have their horses checked by local veterinarians** (provided and paid for by the organizer).
2. Consent to temporarily have their horses stabled in a quarantine stable (inside the event area) **should** the veterinarian staff **detect any symptoms** and would/should want to run **more indepth checks**.
3. **Deliver the original of the negative test (PRC)**.

## During the event

Each owner/rider/responsible for the care of the horse should meticulously follow the following indications:

1. **Check and regularly keep track of the rectal temperature TWICE a day** (morning and evening), normal horse temperature below 38.5 C°.
2. Check the **consumption of food and water**.
3. Verify **nasal or eye discharge**.
4. Observe **the balance and movement of the horse**, with particular attention to hindquarters.
5. Check the **regularity and consistency of bowel movements**, and in particular urination.
6. Immediately contact the **Staff Veterinarian** should you have any **doubt and/or suspicion** regarding **the health conditions of your horse (the telephone number is on each stall door)**
7. Shared tack (lunges, headstalls, thermometers, etc.) organic residue strictly must be cleaned and disinfected before use.
8. Each horse will have its own equipment (feed and water buckets, bridles, etc.).
9. Equipment such as saddles, blankets, leg wraps, etc., must be washed and dried if used on another horse. Disinfectants are recommended during the rinsing cycle.
10. Cleaning of stalls by your own staff must be done at least twice a day.

  - a) Did not have a temperature above  $> 38,5^{\circ}$  C prior to transportation.
  - b) In the past 21 days did not present symptoms attributable to an infectious respiratory disease (for example: cough, nasal discharge, respiratory difficulty) and/or neurological (for example: difficulty in balance and movement of the horse, weakness, difficulty in maintaining upright position, difficulty in urinating) and/or temperature ( $\geq 38,5^{\circ}$  C).
- 2) That in the stable/stables of origin of the below listed horse/horses:
  - a) In the past 21 days the horses already present in the stables did not present symptoms attributable to an infectious respiratory disease (for example: cough, nasal discharge, respiratory difficulty) and/or neurological (for example: difficulty in balance and movement of the horse, weakness, difficulty in maintaining upright position, difficulty in urinating) and/or temperature ( $> 38,5^{\circ}$  C).
  - b) In the past 21 days horses were not introduced and/or moved unless they participated in competitions of national interest of official circuits, as per relative current legislation.

## INFORMATION ON PERSONAL DATA PROCESSING

Pursuant to EU Regulation no. 679/2016 (GDPR), information is provided below regarding the processing of personal data of subjects participating in sporting events under FISE until May 23, 2021.

### **Type of personal data processed and of interested parties**

Within the limits of the purposes and methods defined in this information, the following are processed:

- a) data relating to body temperature;
- b) data relating to non-submission to quarantine measures.

The personal data being processed refers:

- a) to members of the Italian Equestrian Sports Federation (FISE). With respect to these interested parties, this information supplements that already provided for the processing of personal data functional to the establishment and execution of the employment relationship
- b) to the collaborators of the Organizing Committee.

### **Purpose and legal basis**

Personal data will be processed exclusively for the purpose of preventing contagion EHV contagion. The legal basis of the processing is, therefore, found in the implementation of the guidelines.

### **Nature of the provision of personal data**

The provision of data is necessary to participate in competitions under FISE until May 22, 2021.

### **Method, scope and duration of the processing**

The processing is carried out by staff and / or collaborators of the Organizing Committee and / or FISE – should information be transferred. With reference to the measurement of body temperature, no data recording is required. The identification of the interested party and the recording of the exceeding of the temperature threshold could take place only if it is necessary to document the reasons that prevented access. In this case, the interested party will be informed of the circumstance. The data will be processed for the time strictly necessary to pursue the aforementioned purpose of preventing the EHV infection and will be kept on file by the Organizing Committee no longer than the term provided by federal guidelines. Personal data will not be disseminated or communicated to third parties, except on the basis of specific regulatory provisions (eg in the event of a request by the Health Authority for the reconstruction of the chain of any close contacts).

### **Rights of interested parties**

At any time, interested parties have the right to access their personal data, to request corrections, updates and relative cancellation. It is also possible to oppose the processing and request its limitation. These requests can be addressed directly to the Organizing Committee. Furthermore, in the event that it is believed that the processing has been carried out in violation of the legislation on the protection of personal data, the right to lodge a complaint with the Guarantor Authority (data protection authority), Piazza Venezia, 11 - 00187 - Rome is recognized.
